Driving Directions from PDX Airport to the Holiday Inn South in Wilsonville:

1. Start out going **southwest**. 0.2 mi
2. Turn **left**. 0.2 mi
3. Turn **left** onto **NE Airport Way**, 1.8 mi
4. Merge onto **I-205 S/Veterans Memorial Hwy** toward **I-84/Portland Salem**. 23.8 mi
5. Merge onto **I-5 S** via the exit on the **left** toward **Salem** 2.5 mi
6. Take EXIT 286 toward Stafford/
N. Wilsonville. 0.3 mi
7. Turn **right** onto **SW Boones Ferry Rd/
OR-141**. 0.1 mi
8. Take the 1st **left** onto **SW 95th Ave**. 0.2 mi
(If you reach SW Pioneer Ct., you've gone a little too far).
9. **25325 SW 95th Ave** is on the **right**.

(The Holiday Inn Portland South is 0.1 miles past SW Commerce Circle.

If you reach SW Ridder Rd, you've gone about 0.2 miles too far).
